- ⇒ The original signed version of this form must be submitted to the Virginia Department of Elections, 1100 Bank Street, 1<sup>st</sup> Floor, Richmond, VA 23219.
- ⇒ All requested information on the form is **required** unless otherwise noted below.
- ⇒ An amended Statement is required to be filed within 10 days of the change if **any** of the information reported on this form changes. Failure to amend this form in a timely fashion may result in civil penalties of up to **\$500** to be assessed according to the procedure described in §24.2-929 of the Code of Virginia.

### **Type of Statement**

- Check the box that applies to the type of Statement that you are filing.

### **Name of Committee**

- Please insert the full name of your committee. Indicate the FEC recognized acronym for this committee and the acronym, if applicable.
