- ✓ LARGE PRE-ELECTION CONTRIBUTIONS MUST BE REPORTED IN WRITING OR ELECTRONICALLY BY THE END OF THE NEXT BUSINESS DAY, DURING THE FOLLOWING TIME FRAMES:
 - ✓ ON AND AFTER THE 12TH DAY PRECEDING A JUNE PRIMARY AND THE PRIMARY DATE,
 - ✓ ON AND AFTER THE 12TH PRECEDING A NOVEMBER ELECTION AND THE ELECTION DATE, OR
 - ✓ ON AND AFTER THE 11TH DAY PRECEDING ANY OTHER ELECTION IN WHICH THE INDIVIDUAL IS A CANDIDATE AND THE ELECTION DAY.

ALL LARGE PRE-ELECTION REPORTS ARE DUE BY 5PM

- ✓ LARGE CONTRIBUTIONS RECEIVED WITHIN THE 24-HOUR PERIOD BEFORE ELECTION DAY, A LARGE CONTRIBUTION REPORT MUST BE FILED ON THE DAY BEFORE THE ELECTION.
- ✓ ANY CONTRIBUTION REPORTED AS A LARGE PRE-ELECTION CONTRIBUTION MUST ALSO BE REPORTED ON THE NEXT REGULAR PORT DUE FOLLOWING THE ELECTION
