Dear Michael,

According to our records as of 07/16/2015, you are registered to vote in the Commonwealth of Virginia. Based on a comparison of voter registration data with other states, it has come to our attention that you *may* also be registered to vote in another state. Therefore, we are writing to notify you of the requirements established under Virginia law in the event that you no longer reside in Virginia.

If you have moved, but still reside in Virginia, state law requires that you update your address. You may do so either online at [elections.virginia.gov/register](http://elections.virginia.gov/register) or by completing and submitting a paper Virginia Voter Registration Application Form available at many locations in your locality, including the office of the General Registrar.

If you no longer reside in Virginia, you must cancel your voter registration. To do so, please complete and mail the REQUEST TO CANCEL VOTER REGISTRATION FORM at the bottom of this letter. Upon receipt of this form, your voter registration in Virginia will be cancelled.

**If you currently reside in Virginia, you are not required to respond to this notice. Your voter registration status in Virginia will not be affected.**




