

• May be postmarked by 6/18/24 deadline if mailed registered or certified USPS mail. Be prepared to provide a copy of the receipt on 6/18/24.

• May be postmarked by 6/18/24 deadline if mailed registered or certified USPS mail. Be prepared to provide a copy of the receipt on 6/18/24.

Must be filed with your first set of Petition pages.

- You may begin collecting signatures on 1/2/24.
- **Signature Requirement**: Outlined in the Candidate Bulletin or ask your local General Registrar how many signatures are required for the specific office you are seeking election.
- You do not need to file all petition pages at the same time.
- The first set of Petition pages filed must be accompanied by your Declaration of Candidacy.

## **Special Elections Deadlines:**

- If this is the 1st November election after the office's vacancy, the filing deadline is 5 pm 8/16/2024
- If this is the 2nd November election after the office's vacancy, the filing deadline is 7 pm 6/18/2024

While **not** part of ballot access, you do need to also ensure you comply with all campaign finance requirements.
