9. If any vacancy exists:
 - (a) Fill as prescribed by § 24.2-203 of the Code of Virginia
 - (b) Administration of oath by Justice Powell to new Elector, if any
10. Election of president of the College of Electors
11. Election of secretary of the College of Electors
12. Electors cast votes for President of the United States. Each Elector votes by roll call.
13. The Secretary of the Electors counts votes cast for each person and reports total votes cast to the President.
14. The President announces the votes cast.
15. Electors cast votes for Vice President of the United States. Each Elector votes by roll call.

16. The Secretary of the Electors counts votes cast for each person and reports total votes cast to the President.
17. The President announces the votes cast.
18. The College certifies the vote for President and Vice President in accordance with the requirements of the United States Code and the Code of Virginia. Each of the 13 Electors signs **eight** Certificates of the Vote (Form SBE-9 or SBE-9A).
19. The Secretary of the Electors assembles **six** sets of Certificates -- each set containing a Certificate of the Vote (Form SBE-9A, or Form SBE-9 if necessary to be completed) and a Certificate of Ascertainment executed by the Governor -- and seals them in the **six** envelopes of endorsement. The sealed envelopes are signed by each Elector certifying that the lists of all the votes of the Commonwealth of Virginia for President, and all of the votes given for Vice President, are contained therein.
20. The **six** sets, as directed by law, are distributed as follows:
 - (a) **One**, forthwith by registered mail, to the Honorable Michael R. Pence, President of the United States Senate, The United States Senate, Washington, DC 20510.
 - (b) **Two**, to the Honorable Kelly Thomasson, Secretary of the Commonwealth of Virginia, 1111 East Broad Street, 4th floor, Capitol Square, Richmond, Virginia, 23219.
 - (c) **One**, to the Honorable Mark S. Davis, Chief Judge of the United States District Court for the Eastern District of Virginia, 600 Granby Street, Norfolk, Virginia 23510
 - (d) **Two**, on December 19, 2020, by registered mail, to David Ferriero, Archivist of the United States, National Archives and Records Administration, 800 N. Capitol St. NW, Ste. 700, Washington, DC 20001.
21. The seventh Certificate of the Vote will be sent to Dr. Sandra G. Treadway, Librarian of Virginia, by the President of the Electors. The eighth Certificate of the Vote will be held by the State Board of Elections until all documents are received, then delivered to the Librarian of Virginia.
22. The Secretary of the 2020 Electoral College shall prepare and read the minutes of the meeting, which are then approved by the College and signed by each Elector.
