**FINAL ORDER AND CERTIFICATION OF ELECTION RESULTS FOR
WESTMORELAND COUNTY BOARD OF SUPERVISORS (DISTRICT 3)**

THIS MATTER came before the Court on December 6, 2023, for a Recount in the November 7, 2023, General Election for the Westmoreland County Board of Supervisors (District 3), (hereafter, the "Election"), pursuant to Petitioner Dorothy Dickerson Tate's Amended Petition for Recount, the Court's preliminary hearing held on November 27, 2023, and the Court's Preliminary Recount Consent Order entered December 4, 2023.

IT APPEARING to the Court that the officials appointed by the Court to implement the Recount have completed the process without objection by the parties and to the Court's satisfaction, that the official Election results after such Recount as set forth in the Recount Certification attached hereto as Exhibit A and incorporated by reference herein should be confirmed, and that the official Election results after such Recount show that matthew D. Ingram received the higher number of votes and thus should be declared the winner of the election.

It is hereby ORDERED and CERTIFIED to the Virginia State Board of Elections and the Westmoreland County Electoral Board that the total votes for Dorothy Dickerson Tate are


595, that the total votes for Matthew D. Ingram are 604, and that the total write-in votes for neither candidate are 0.


It is further ORDERED and CERTIFIED that Matthew D. Ingram hereby declared elected to the Westmoreland County Board of Supervisors, representing District 3.


And it is further ORDERED that the costs of the Recount shall be assessed to Petitioner pursuant to Virginia Code § 24.2-802.3.

This cause is concluded.






