**FINAL ORDER**

**THIS MATTER CAME** before the Recount Court, consisting of the Honorable Kimberly A. Irving, Chief Judge of the Thirty-First Judicial Circuit; the Honorable Richard B. Campbell, Judge of the Thirteenth Judicial Circuit; and the Honorable Randall G. Johnson, Jr., Judge of the Fourteenth Judicial Circuit, upon a Petition for Recount of the Republican primary for the Twenty-Ninth Senate District of Virginia filed by the Petitioner, Maria E. Martin; and

**IT APPEARING** as follows:

1. This Court, being duly designated and convened by the Chief Justice of the Supreme Court of Virginia on July 12<sup>th</sup>, 2023, set the recount to begin on July 20<sup>th</sup>, 2023, at 9AM;
2. Further, the Court set the preliminary procedures of this recount by Preliminary Order dated July 17<sup>th</sup>, 2023, and then finalized such procedures by Final Recount Order dated July 19<sup>th</sup>, 2023;
3. The recount began at such time as designated and continued to July 21<sup>st</sup>, 2023;
4. This Court then heard the motions as were filed by the parties and resolved such motions by Order dated July 21<sup>st</sup>, 2023, titled Order Regarding Recount Motions;
5. Thereafter, the recount continued until the General Registrars of each respective County comprising the Twenty-Ninth Senate District notified this Court that the recount was concluded and submitted the statements of results to the Court;

6. The Court thereafter ruled upon any challenged ballots, of which there were none;
7. Based upon such ballots, statements of results, and rulings of this Court, this Recount Court does hereby

**CERTIFY and DECLARE** the following to the State Board of Elections, the parties, and the relevant Electoral Boards:




Maria E. Martin: 2,603


Nikki R. Baldwin: 2,605


